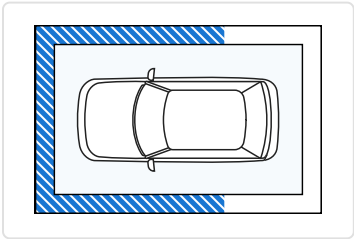

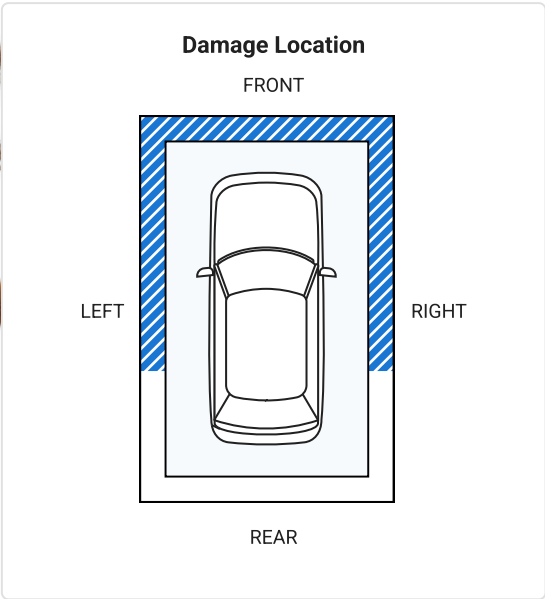

Glossary

Accident Indicator

Airbag Deployment

New Owner Reported

Ownership History
